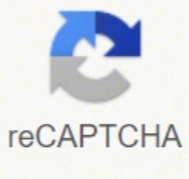
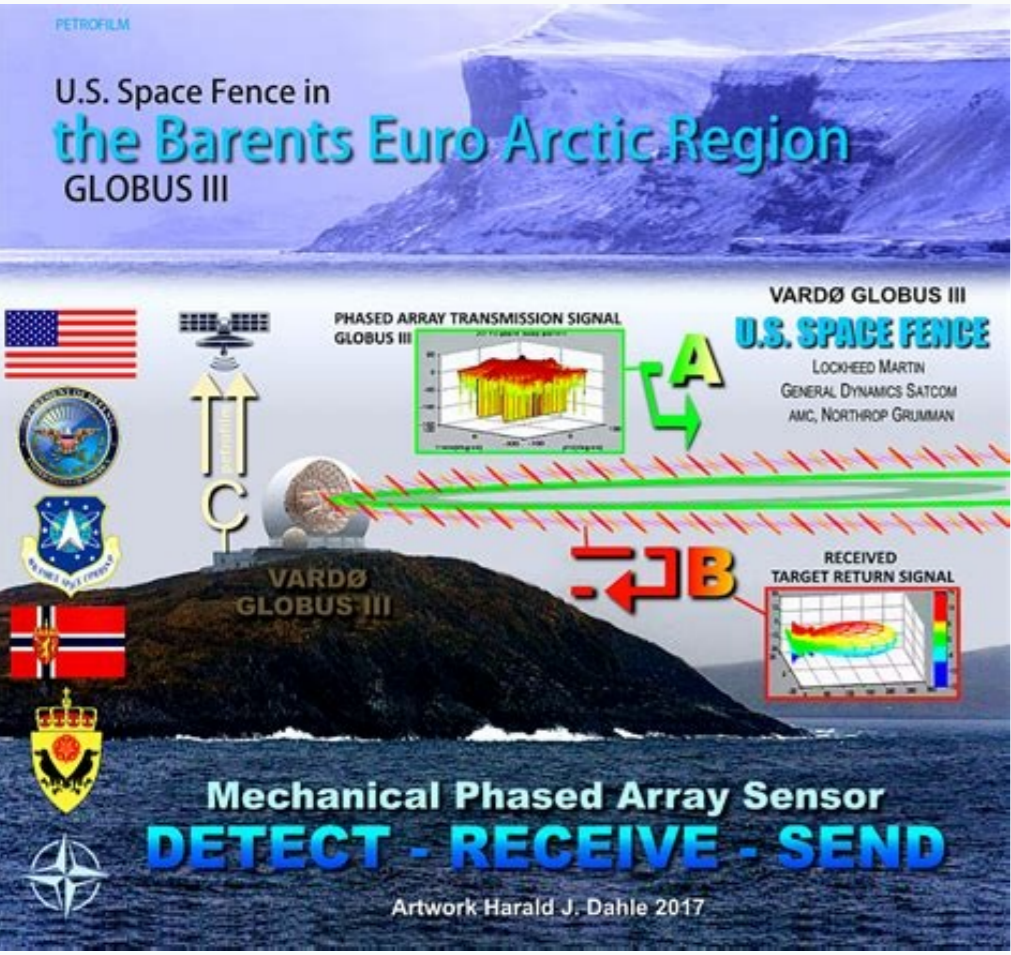
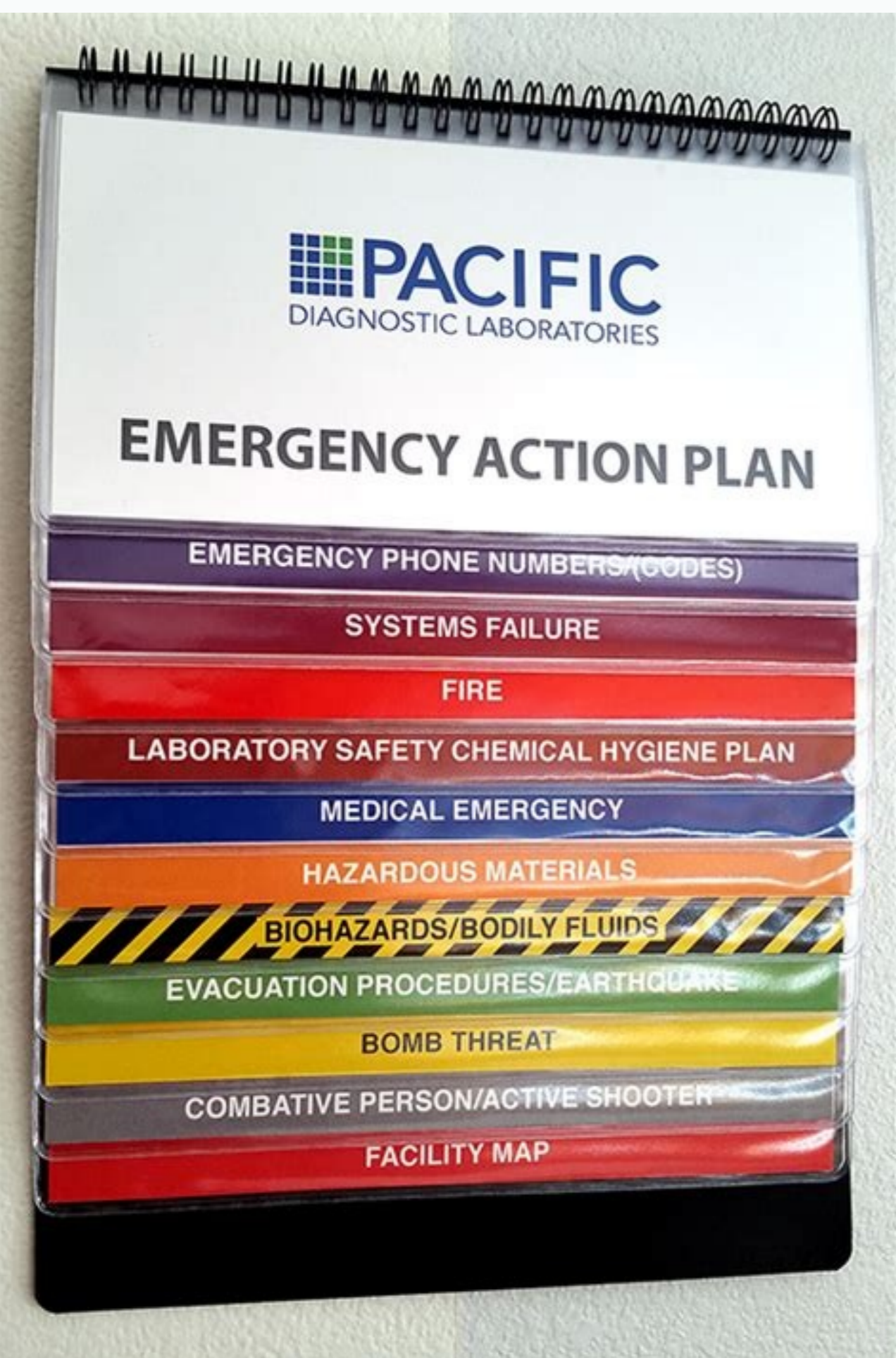

The alarm continues until it is officially restored by security. If they decide not to follow them, leave them behind. If you are near the museum entrance, you should go out with your group. One inside to the right of the West Doors up to the Steele pre-function. In case of minor medical problems (fall, impact, cut, fainting but conscious) during the tour, the guide should ask the group to remain silent at this location. Unable to shoot, act with extreme physical aggression; do not worry about the comfort or the shouts of the shooter. Do not move the victim unless absolutely necessary. Lights out. Look for exit signs, plan escape routes. When it's safe, only one person calls 911, indicates your location. Except with Security do not discuss the possible cause of an accident or any condition that may have contributed to the cause. Wheelchairs are available to visitors at the security desk upon entry. In the event of a serious medical emergency (heart attack, fainting, life-threatening) call 911 immediately and then alert security. You may have to wait 72 hours. Bear in mind that you do not try to leave in your vehicle, you may cause yourself serious injury or injury to yourself or others. An active shooting scene can' last 4-7 minutes. Please proceed to the nearest exit' and do not use the lift. If possible, quit quickly / quietly, advise others you see to follow you. As a last resort, fight the aâarm with a heavy object; Drop objects, fire extinguisher, books, shoes, etc. When the alarm sounds, follow the instructions above. If inside, hide the sight of the shooter, lock or barricade doors, if possible. The driver must immediately go to the admissions safety desk to alert the in-service safety officer or alert any road safety officer to the admissions of the situation. Avoid asking for help or directions when evacuating. Each time you hear the alarm, you should immediately stop the group you are making and escort the group to the nearest exit. Exiting, breaking windows/corners are the weakest'. Under no circumstances should you discuss any insurance information with members of the public. Move away from the sound of gunshots and away from Windows and Scagli. Avoid unnecessary conversation with or about the sick or injured person. If the path to the man's old or new entrance is blocked, leave the building immediately through the nearest exit to the outside. out of.
